### Mr. István Szabolcs Ferencz

Before taking up his position as Senior Vice President of Corporate Affairs – supervising Strategy Development, international and domestic governmental relations, groupwide Regulatory Affairs and Corporate Communications –, Szabolcs I. Ferencz was CEO and Country Chairman of MOL Romania, a key MOL Group subsidiary. Previously he held the position of Vice President MOL Group Corporate Communications and was in charge of the overall communications activities of the fast growing Group. Before joining MOL Group in 2003, Szabolcs I. Ferencz worked in government and political communications. In 1998, he was appointed Director of Communications for the Hungarian Prime Minister's Office, working directly for the Prime Minister. # Mr. Ferenc Horváth

### Mr. József Molnár

From 1978 to 2001 Mr Molnár held various management positions at BorsodChem Plc, including Head of the Pricing Department from 1982 to 1987 and Head of the Controlling Department from 1987 to 1991.
